

How Charity is constituted: Trust

Trustee Selection: Appointed by the existing trustees

Other governance details:

The charity is run on a day to day basis by the Director and Assistant Director with help from a team of volunteers.

The charity employs a Country Manager to undertake monitoring and research of School Links and Projects in Ethiopia.

There is a Child Protection Policy in place that was adopted by the trustees on 8th March 2007.

Trustee remuneration:

The charity has undertaken a joint fundraising project with the Aysanew Kassa Trust of which Jean Bailey (Trustee) is director. She received no remuneration from the Aysanew Kassa Trust.

No Trustees received any remuneration during the period.

Summary of the objects of the charity set out in the governing document

The advancement of education and the relief of poverty in Ethiopia and the promotion of racial harmony between the young people of the United Kingdom and Ethiopia.

Summary of the main activities in relation to these objects

- Establishing and supporting School Links between UK and Ethiopian schools at all levels. This programme works to improve cultural awareness and racial harmony alongside supporting curriculum development to help advance education in both countries.
- Resourcing and Community Projects in Ethiopia, particularly in rural schools, include the building of new classrooms, providing water facilities and sanitation together with the resourcing of school libraries. This helps the advancement of education and the relief of poverty in these areas.
- Our Volunteer Teaching programme places pairs of volunteers in Ethiopian secondary schools for 3 month periods to teach English communication skills. This scheme directly supports the education of many young people in Ethiopia whilst giving the volunteers invaluable experience working in a different culture.

Additional Details

A great contribution is made by volunteers. We are grateful for the many hours volunteers have given us and without this valuable contribution of time, energy and expertise we would not have been able to achieve so much.

Summary of the main achievements of the charity during the period

The charity was set up in September 2005 taking over the Ethiopian activities of the DCGS Fund together with funds of £41,993.

School Links

- 3 new secondary school links established to make a total of 6
- 9 new primary school links established to make a total of 13
- Teacher visits from four members of staff from four linked schools
- Sixth Form group trip from a secondary school
- Hundreds of letters sent between UK and Ethiopia

Resourcing and Community Projects

- Building three new classrooms in rural schools to allow hundreds more children to attend school
- Construction of two new clean water facilities to improve the health and hygiene of students
- Building of a toilet block in an urban school to improve the health and hygiene of students
- Resourcing of libraries through a shipment of 25,000 books to linked schools
- Provision of improved technology through shipping 16 computers for various linked school and installing internet in an urban secondary school
- Funding of the 'Clean Gondar' project which pays street children to help clean part of their community
- Sponsoring of individual children in collaboration with UK schools

Volunteer Teaching

- Four pairs of volunteer teachers at the Fasiledes Secondary School
- Expansion of Gap Ethiopia scheme to the Azezo Secondary School where one pair have now completed their teaching placement

Other

- Employment of a Country Manager in Ethiopia to oversee all activities there
- Acquisition of an office in Gondar, Ethiopia
- Recruitment of UK volunteers: Communications Officer, two Fundraising Officers and a new Gap Ethiopia coordinator.

Financial Review

This initial period reflects receipt of initial funds totaling £41,993 from the DCGS Fund. This was by definition one off in nature.

Policy on Reserves:

- As at 05/04/07 the charity held funds of £22,486. Of this amount £20,036 was in un restricted funds.
- The charity aims to have between £5,000 and £8,000 on deposit in unrestricted funds at all times to meet any unforeseen expenses that may occur in meeting its aims and to bridge any temporary gap in income.
- The trustees have determined that £10,000 of the current funds will be allocated for salary for a UK based employee in the future.
